Nagaraju & Associates, Mysuru with FRN 014283S be appointed as Statutory Auditors to hold office from the conclusion of this meeting till the conclusion of the ensuing Annual General Meeting. An EGM to be held to confirm the said Firm's appointment within three months. Terms of appointment of appointee audit firm shall be on the agreed terms between incoming auditor and the Company represented by its Chairman. The appointee firm will audit the accounts of the Company for the financial year 2018-19. The Board noted from the draft mail communication of even date that the firms appointment if made shall be in accordance with Sec 139(8) read with Sec 141 of the Companies Act 2013 and further noted the eligibility and also that the firm satisfies the criteria for appointment and is qualified u/s 141 of the said Act.

The Chairman was authorized to upload ADT-1 using his digital signature to MCA website and BSE Listing Centre the Firms appointment.

Sri Rama Rao was advised to collect his consent letter of even date in exchange of this certified Resolution.
